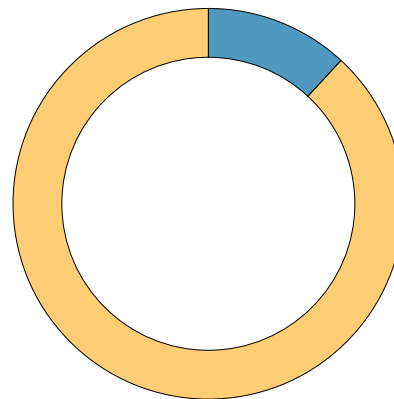

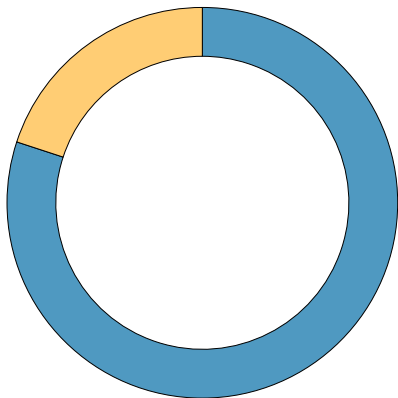

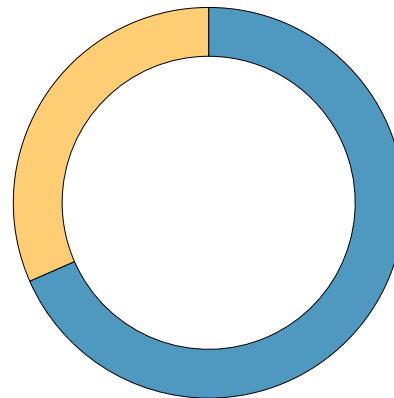

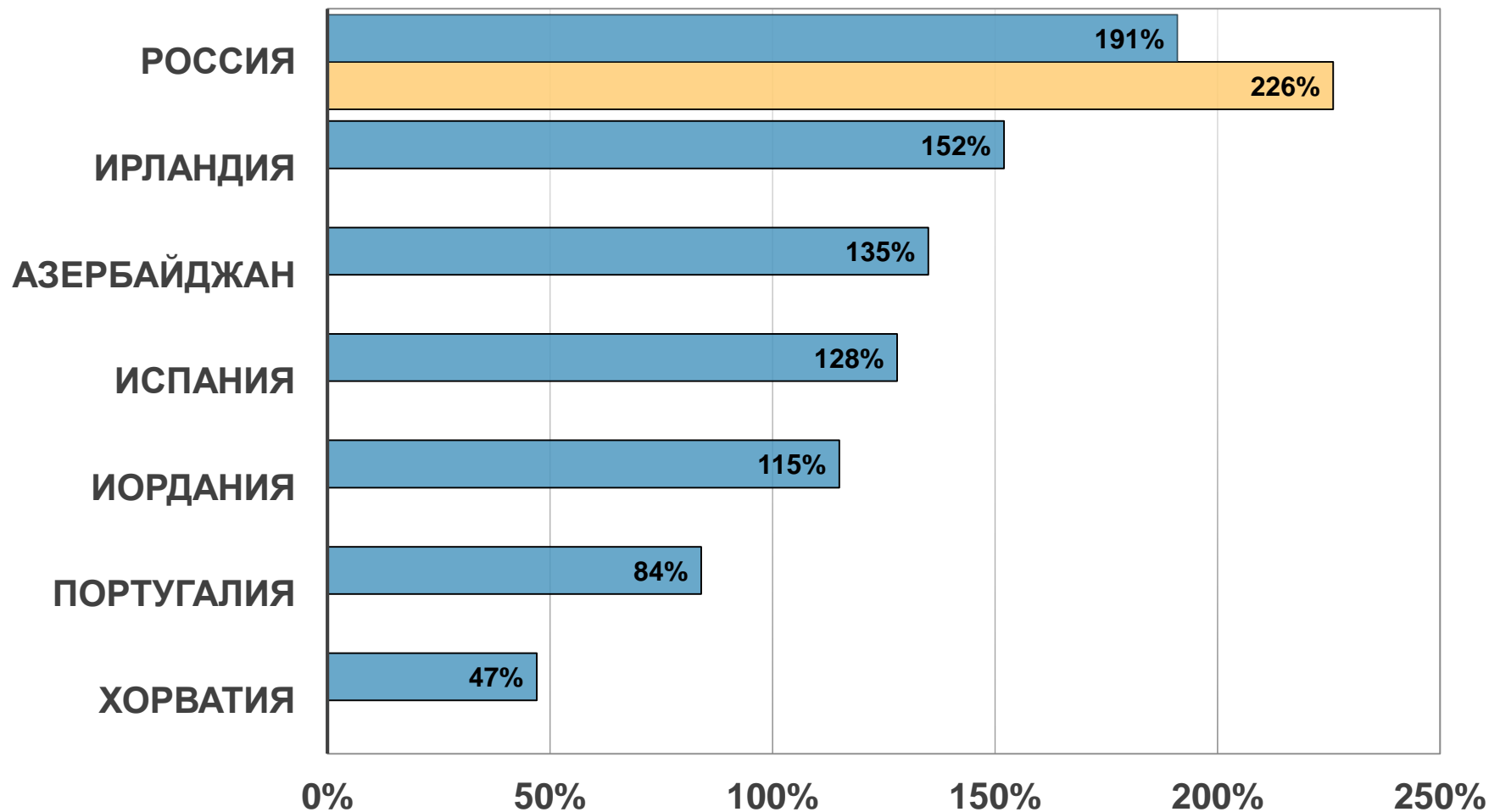

Доля долга в иностранной валюте падает

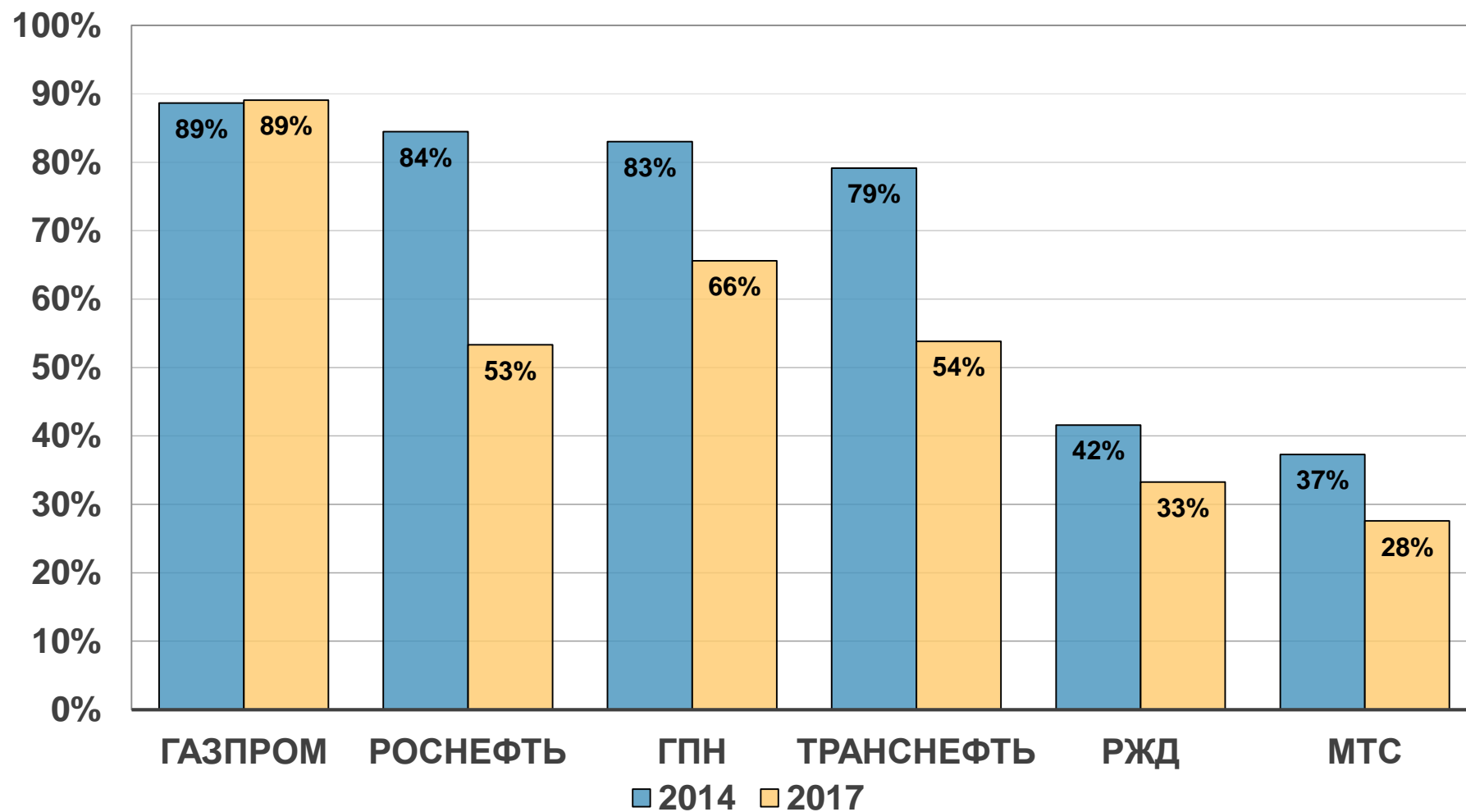
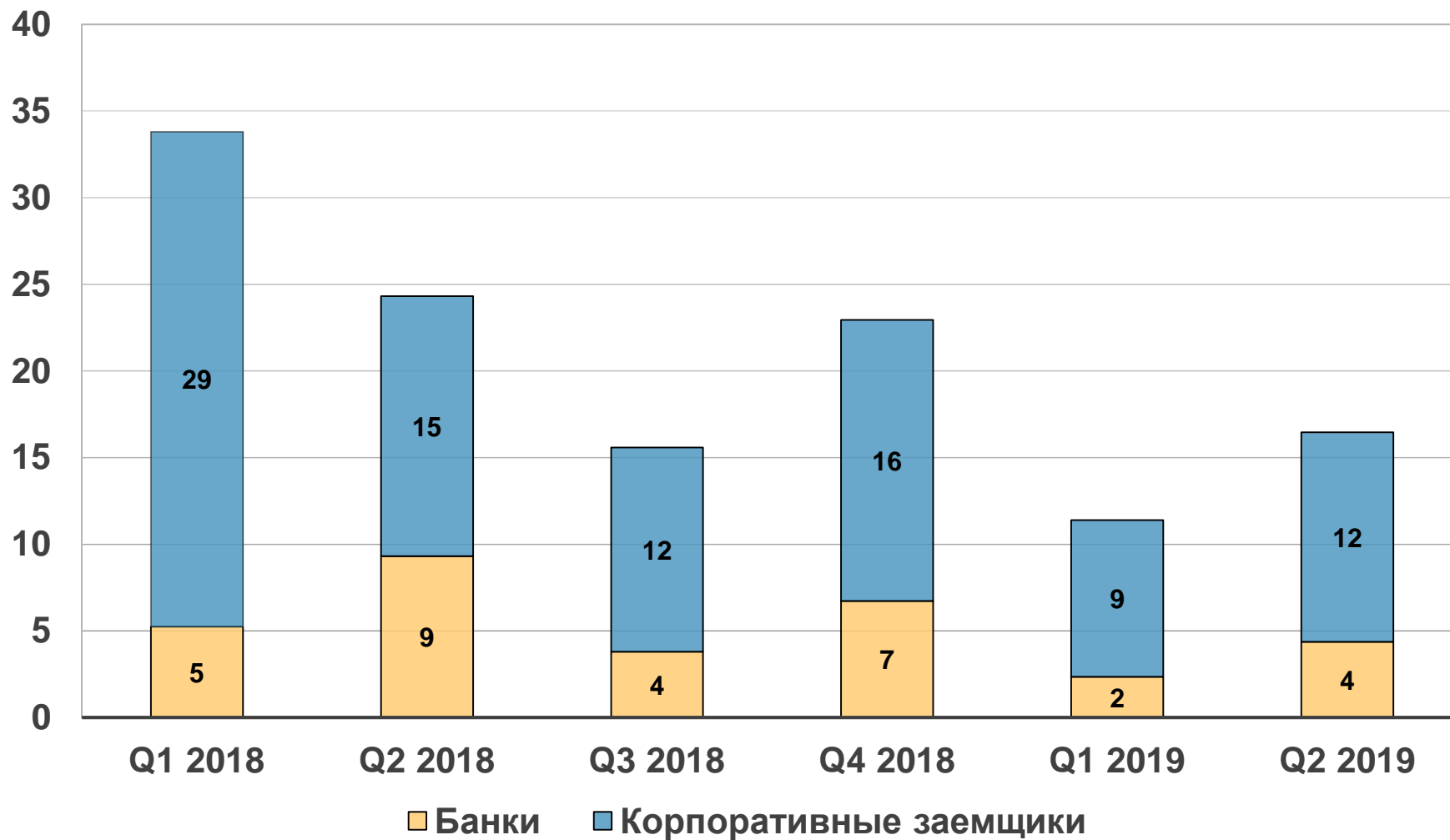


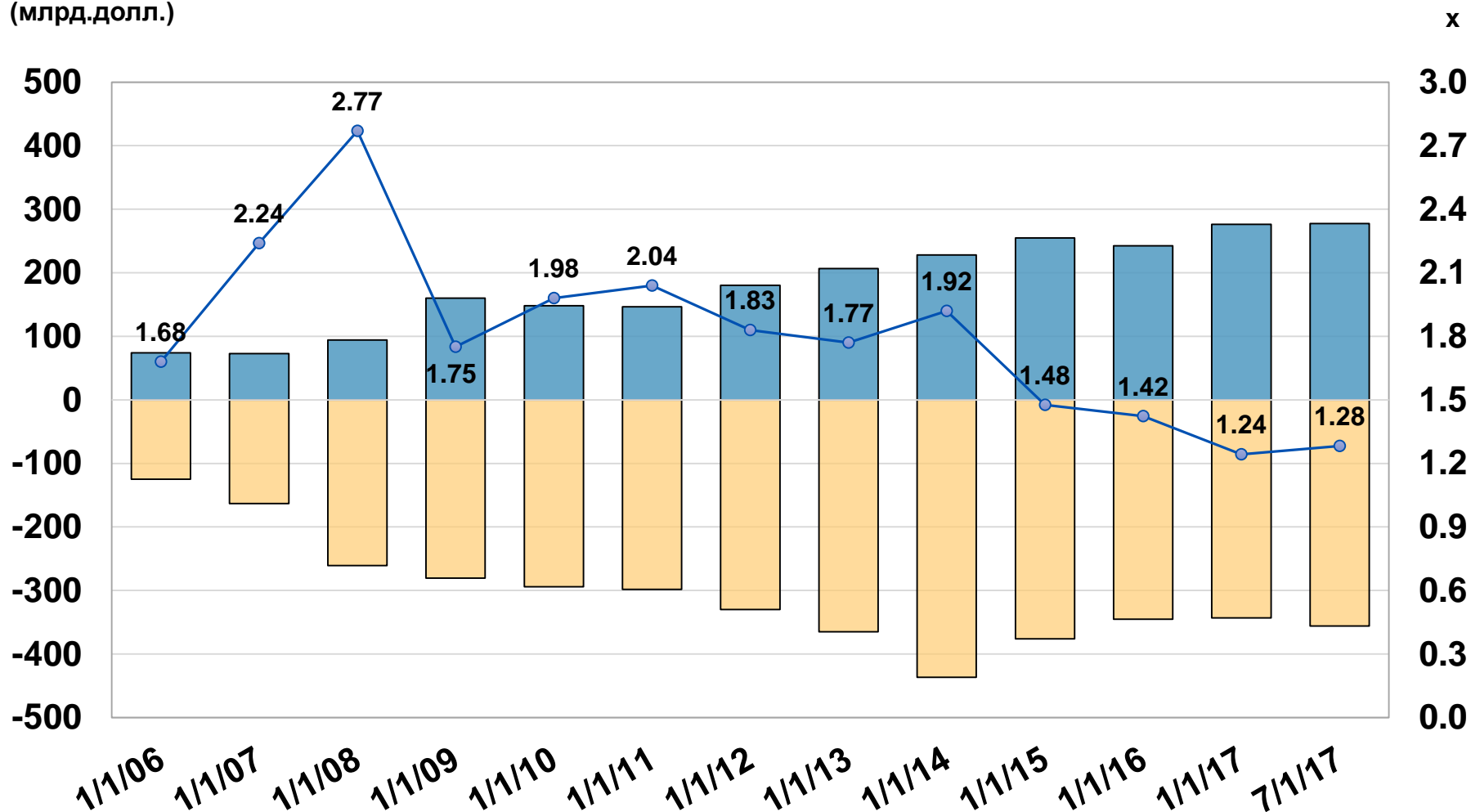
График погашения внешних заимствований

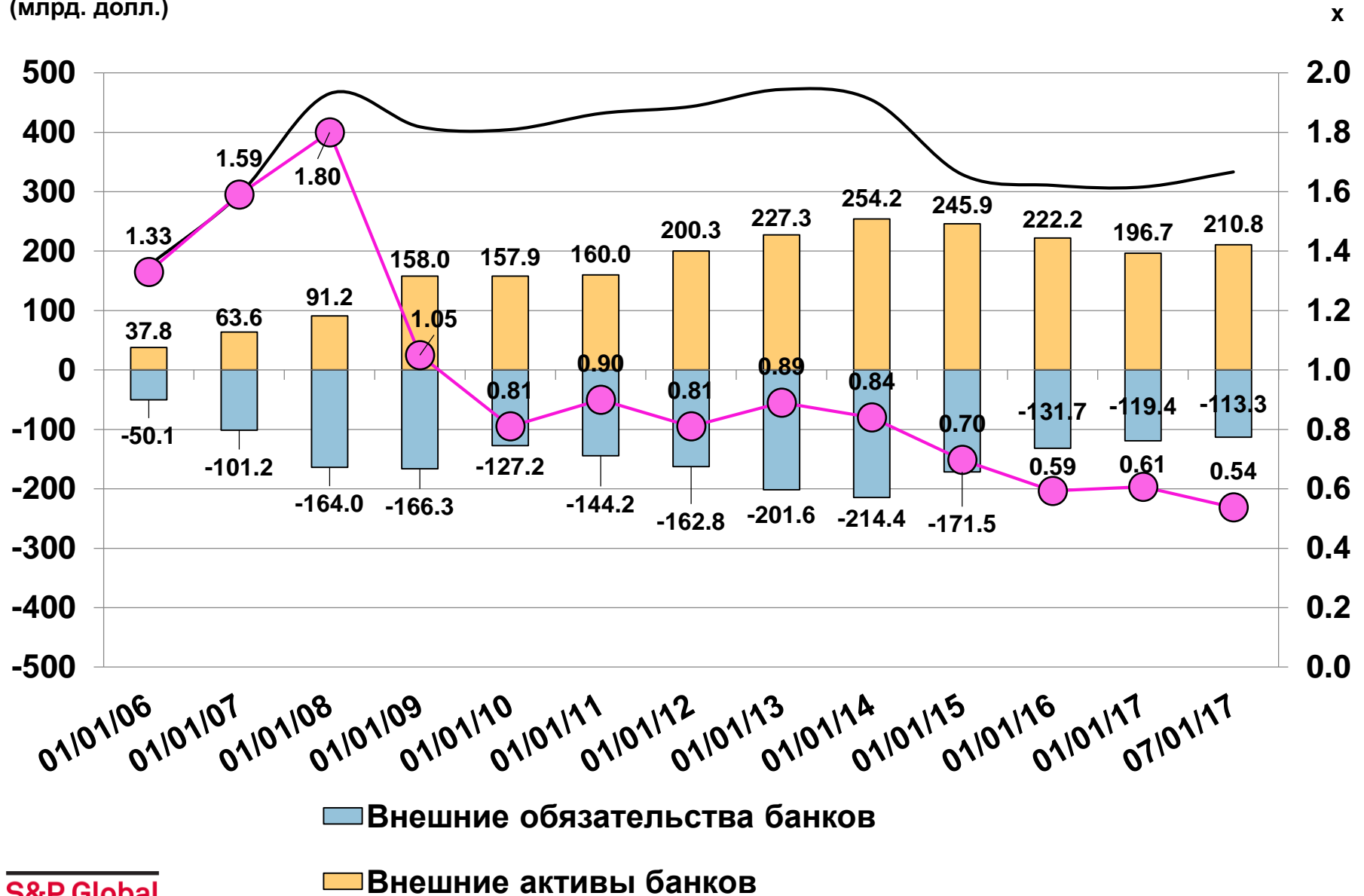

- Внешние обязательства / внешние активы (правая шкала)

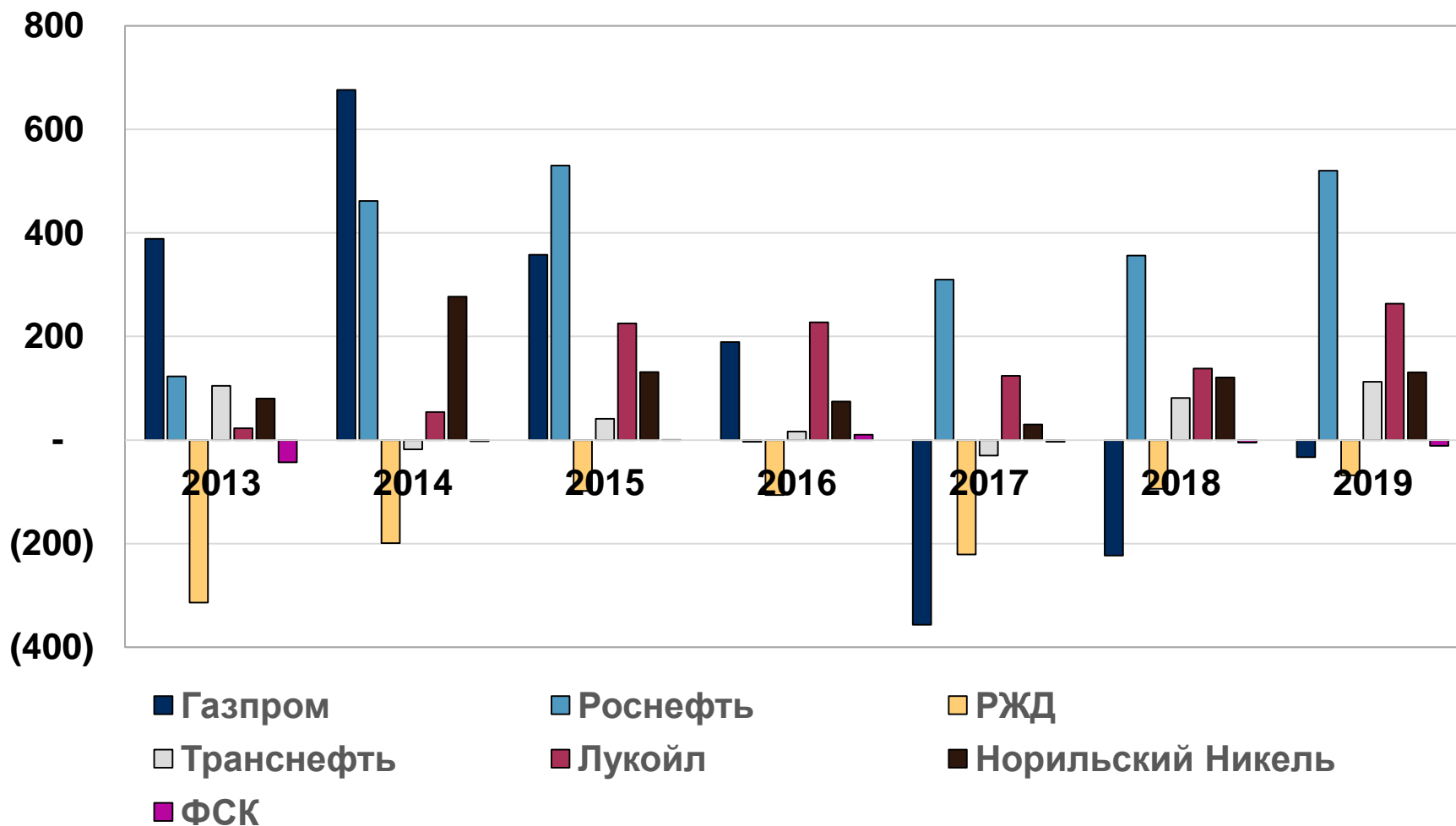
