Investment Funds

Our strategy and approach to leveraging market volatility have yielded significant results

Fonte Emerging Markets Umbrella Fund

Organized as an umbrella fund, it includes sub-funds with separate investment portfolios within the main fund, each having its own unique investment objectives, strategies, and assets.

Fonte Innovation Fund

A fund aimed at capital appreciation through the acquisition of digital assets (cryptocurrencies).

Fonte Hedge Fund

The fund is aimed at ensuring long-term capital growth for shareholders through active management of a securities portfolio, focusing on fixed-income instruments in emerging markets and Eurobonds.

Fonte Inceptia Alpha

The fund focuses on managing a portfolio of options on stocks, contracts for difference (CFDs), and shares of American and European companies.

Fonte Exponential Fund

A fund aimed at long-term capital appreciation through investments primarily in bonds and other fixed-income instruments, as well as stocks in emerging markets. The majority of transactions are conducted in over-the-counter (OTC) trading.

Fonte Dynamic Fund

A fund focused on investing in a portfolio diversified across a wide range of asset classes, markets, and instruments, actively employing various non-conservative and high-risk strategies to achieve exceptional returns.

Fonte KZ Fund

The fund invests in securities of Kazakhstani issuers, including shares of large companies and debt instruments of corporate and quasi-governmental organizations

Fonte Universal Fund

The fund is focused on managing a portfolio of stock options, contracts for difference (CFDs), and shares of American and European companies.

Fonte Temir Fund

The fund primarily invests in fixed-income debt securities without preference for maturity dates, corporate debt securities from emerging markets, and Eurobonds.

Fonte Health Sciences Fund

The fund's investment mandate focuses on financing projects in the fields of medicine and healthcare, as well as supporting initiatives that contribute significantly to the development of biomedical technologies and innovative solutions in life sciences

Fonte Greenmet Investments Fund

The investment objective is to ensure income and medium- to long-term capital appreciation through investments or exposure to: fixed-income securities, corporate debt obligations, and shares of companies operating in the metallurgy and mining sectors

Fonte Universal Fund

The primary objective of the fund is to invest in financial institutions and fintech companies that are directly or indirectly related to financial institutions

One of the key advantages is the ability to conduct transactions in foreign currency with both residents and non-residents of Kazakhstan, rather than solely in KZT. This provides investors with the freedom to choose their preferred currency, taking into account their needs and managing currency risks effectively



MULTI-LEVEL CONTROL

The fund's activities are supervised by an independent financial services regulator, AFSA (Arctic Financial Services Authority). In addition, rigorous internal control is conducted over risk management, investment policies, and compliance with regulatory requirements

In-depth research and comprehensive analysis

 Careful examination of financial statements, management teams, and market trends allows us to make well-informed investment decisions and select the most promising assets

 We regularly review company reports, analyze management comments, and monitor news and strategy updates. This consistent approach over an extended period creates significant added value. Analyzing each quarterly report throughout the year is far more effective than trying to review numerous reports in a short time frame

Long-term growth through compound interest

 The Fund focuses on identifying undervalued stocks for medium- and long-term investments, allowing us to acquire assets at more attractive prices

 The Fund invests in assets with stable cash flows and reinvests earnings to maximize the benefits of compound interest. Advantages of the Fund's strategy:


 Value investing works in both growth periods and times of turbulence. We aim to preserve and increase our ownership stakes through the competitiveness of our companies, even in times of economic contraction

 While the market is focused on large tech companies, there are high-quality, growing businesses with competitive advantages among small- and mid-cap companies. These companies are often valued at just 5-8 times their annual earnings, making them undervalued

 Some of these companies provide double-digit returns to shareholders through dividends and share buybacks, regardless of market fluctuations



Fund Strategy

Based on the search for undervalued assets, observed mispricing may result from the market's overreaction to negative or positive events. This effect can be a consequence of the "attention economy"

Mispricing

The development of the stock market has led to an increase in the share of retail non-professional investors. This type of investor may overreact to negative or positive news ("herd effect"), which may not significantly impact the asset's value. As a result, the market price of an asset can deviate significantly from its fundamental value for a period of time. Thus, the Fund's strategy consists of identifying and exploiting such market inefficiencies

Options Portfolio Management

Focuses on identifying undervalued opportunities, allowing for the exploitation of anticipated market movements while managing risks effectively

Investing in CFDs

It is used for hedging positions and profiting from short-term price fluctuations without the need to fully acquire the asset

Stocks are selected based on fundamental analysis and macroeconomic factors, allowing for profit generation from both growth and stability of high-quality companies with long-term potential

Comprehensive Strategy

Provides a balanced approach to investing with a focus on maximizing returns and minimizing risks
